

2010 Multi-Cultural Arts, Crafts & Antiques Expo

Williams, Arizona June 18th – 19th, 2010

Show Times: Friday June 18th from 10am to dusk. Saturday June 19th from 10am to dusk. Live entertainment will be going on during those times both days. Remember the Grand Canyon Railway train returns at 5:30pm each evening bringing many more visitors/customers! Vendors are asked to stay open until at least dusk or longer.

Booth Location: Williams and Forest Service Visitor Center Parking lot. 200 W. Railroad Ave. Booth spaces will be assigned by the Multi-Cultural Expo Committee. A directional map will be mailed to you upon acceptance of your application. Information on services, campgrounds, etc., available in the area will also be mailed to you.

Booth Delivery and Set-Up: Exhibitors must provide their own booths and booth set-up materials. Exhibitors shall be liable for delivery, handling, erection and removal of their own displays and materials. Set up may begin at 4p.m Thursday June 17th and must be completed by 10am Friday June 18th. All vehicles must be removed from the area. Parking will be provided at the City Parking lot on the corner of Grand Canyon Blvd. and Railroad Ave.

NO stakes, spikes or etc. shall be put in the ground. Please bring weights to hold your tents down. Although we would like to control the weather, please plan for all conditions.

Electricity: Electricity will be provided at an additional cost as specified in the application.

Litter: All booth areas must be kept free of litter. Trash containers will be provided by the Williams-Grand Canyon Chamber of Commerce throughout the exhibit area. Exhibitor is responsible for ensuring that their booth area is left clean and free of trash.

Pets: Pets are *not* allowed in the vending area during the event.

Local Codes and Laws: All pertinent fire codes, laws, ordinances and regulations pertaining to health, fire prevention and public safety shall be strictly obeyed.

Security: No dedicated security is provided. Regular patrols of the area are conducted by the Williams Police Dept.

Camping: No camping will be allowed. Nearby campgrounds are available for overnight use for a fee (Williams-Grand Canyon Chamber of Commerce does not set the camping fees).

Vehicles: No venter vehicles will be allowed in the display area during designated operating hours.

Approval of Merchandise: *This is a juried show.* Items must be of an arts and crafts nature. The Multi Cultural Expo Committee will prohibit the installation and operation of any exhibits not meeting their approval.

Liability: Williams-Grand Canyon Chamber of Commerce, Main Street Assoc. and the City of Williams will *not* be liable for refunds or any other liabilities whatsoever for the failure to fulfill these terms and conditions due to fire or other calamity, or by any act of God, public enemy, strikes, statutes, ordinances or any legal authority, or any cause beyond the control of the William-Grand Canyon Chamber of Commerce, Main Street and the City of Williams.

Insurance: Exhibitor at his or her own expense may obtain Liability Insurance. Williams-Grand Canyon Chamber of Commerce, Main Street and the City of Williams assume *no* risk. Additional Insured clauses to be added as requested.

Sales Tax: Exhibitors are solely responsible for collection and remittance of sales tax to the State of Arizona and the City of Williams. All exhibitors must have an Arizona transaction privilege tax license obtainable through the Arizona Department of Revenue (602) 542-4565.

Waivers: No waivers, modifications or amendments shall be valid unless approved in writing by the Multi Cultural Expo Committee. Venue for all legal proceedings arising from violation of these terms and conditions must be initiated in Coconino County, Arizona.
